Pending the *inter partes* hearing and determination of the Petitioners/Applicants' Notice of Motion Application dated 13/05/2025, a conservatory order be and is hereby issued restraining the Respondents, jointly and severally, and whether directly or through their employees, servants, agents, their related entities, entities under their regulation or supervision, or entities or bodies operating with them under a multi-agency framework from unlawfully causing, directing, enforcing, implementing or allowing to be implemented any wholescale shutdown, blockage, denial of access or service, or causing to become offline of the internet or internet/data services, telephony services, electronic communication platforms, social media platforms/applications/sites or similar services and facilities.

2. Pending the *inter partes* hearing and determination of the Petitioners/Applicants' Notice of Motion Application dated 13/05/2025, a conservatory order be and is hereby issued directing the Respondents, jointly and severally, to collate and preserve all information, documents, material, correspondence, directions, memoranda and such other similar items on or related to the alleged previous wholescale shutdown, blockage, denial of access or service, or causing to become offline as disclosed in the Application and the Petition.

3. The Petitioners shall serve the Application, Petition, Supporting Documents and this Court Order on the Respondents and the Interested Parties by close of business 15/05/2025 and file an Affidavit(s) of Service in that regard by close of business 16/05/2025.
